Terms and Conditions for Dining Services Contract

1. The University of Pittsburgh at Johnstown offers the following meal plans for the 2018-2019 academic year. Guest Meals are **not** additional meals; they are included in the total number of meals. When using your Guest Meals you must inform the cashier at the point of sale. *All meals, dining dollars, and guest meals are per term.*

PLAN 1	8 Guest Meals/Term	
Formerly (1B)	200 Meals w/275 Dining Dollars (Approximately 12 meals/week)	\$2070

PLAN 2	6 Guest Meals/Term	
Formerly (2B)	150 Meals w/350 Dining Dollars (Approximately 9 meals/week)	\$1910

PLAN 3	4 Guest Meals/Term	
Formerly (2C)	125 Meals w/475 Dining Dollars (Approximately 8 meals/week)	\$1910

DECLINING BALANCE PLAN		
(Commuters; Townhouse Residents, and College Park Apartment Residents Only)		\$ 500

All upper-class students contracted by the University to reside in any residence facility with the exceptions of the Townhouses are required to contract for a meal plan. Any resident student not residing in the Townhouses who fails to choose a dining plan during the contract period will be automatically contracted for Plan 1 at \$2070/term. Townhouse residents may choose any of the aforementioned plans. If a student makes a housing assignment change at any time, the student will be subject to these guidelines as they apply to their new housing assignment. **All first year FRESHMAN housing students are required to select a meal plan; they must choose from Plan 1 or Plan 2.**

2. Changes to dining plans will be permitted following the contracting period through summer break until the end of the third day of the Fall semester. Spring term changes may be made throughout November until the end of the third day of the Spring semester. These are the only periods of time that a student may change their meal plan while remaining within the boundaries as described above. The presence of a service hold from any university agency will prevent a requested change from occurring to any meal plan.
3. **Meals and Dining Dollars DO NOT** carry over from term to term. Dining Dollars may be used at any dining services point of sale including the Tuck Shop, the Varsity Café, the Mt. Cat Club, The Daily Grind, Brioche Dorée, and the Student Union Dining Hall. Meal Plan Dining Dollars cannot be used in the Bookstore. Meals may only be used at the Student Union Dining Hall and the Varsity Café. Any remaining Dining Dollars and/or meals at the end of the Fall or Spring terms will be forfeited. Balances for Dining Dollars and meals can be checked daily by logging in to Campus Services or they can be provided at any point of sale from dining services.
4. Student meal plans are not transferable. Anyone contracting for a meal plan will be held liable for the illegal use of the meal plan and may result in the forfeiting of the meal plan without refund.
